Definitions	
<b>1 Ceased Mulesing</b> (if Box is Ticked)	(a) <b>Sheep are bred on the property:</b> An entire drop of non-mulesed lambs/young sheep must have been shorn to obtain Ceased Mulesing status. To retain Ceased Mulesing status, there must be no further mulesing on the property. (b) <b>ALL sheep are brought onto the property:</b> Mulesing is not performed on any mob on the property.
<b>2 Mulesing</b>	The removal of skin from the tail and/or breech region of a sheep using shears.
<b>3 Contact with Shedding Breeds</b>	Mated to, or run in the same paddock as shedding sheep/lambs or their crosses.
<b>4 Shedding Breeds</b>	Breeds that shed dark and/or medullated fibre (e.g. Awassi, Damara, Dorper, Wiltshire Horn). Refer AWEX Woolclasser Code of Practice.
<b>5 Mob Mulesed</b>	If mob contains both mulesed and non-mulesed sheep, respond Yes, Mob Mulesed.
<b>6 Pain Relief</b>	(a) Pain Relief product must be registered by, or be supplied under permit from, the Australian Pesticides and Veterinary Medicines Authority for use with sheep. (b) Proof of purchase will be required in the event of an audit.
<b>7 Record Kept of Chemical Use</b>	If Yes (Y), details of mob, date, purpose, type and amount of chemical(s) must be recorded. If chemicals are not used, a record must also be kept of this.
